

Biostime Reinforces Cooperation with La Laiterie de Montaigu in the Field of Infant Formulas Supply for the PRC Market

By renewing this long-term manufacturing agreement, we will be able to ensure sufficient and stable supply of high quality products and we look forward to making joint efforts with La Laiterie de Montaigu to continue develop safe and innovative premium products for Chinese consumers and capture the huge potential of this flourishing market."
